The 69<sup>th</sup> annual conference of the National Association of State Workforce Agencies (NASWA), recently held in Rapid City, Sept. 12-15, was a huge success for the South Dakota Department of Labor (SDDOL) and the NASWA organization.

Approximately 200 people from around the nation attended the conference. The theme of the conference was "Great Faces, Great Places" and revolved around showcasing South Dakota's hospitality.

The festivities kicked off with a pre-conference welcome picnic in Memorial Park in Rapid City on the evening of Sept. 11. Nicer weather could not have been asked for, the food prepared by the culinary arts team at the Boxelder Job Corps Center could not have been better, and the Black Hills Bluegrass Band offered a down-home, heartland welcome. An evening hospitality room graciously sponsored by the South Dakota Chapter of IAWP kept

attendees fed and 'relaxed' with South Dakota wines, fine spirits and South Dakota featured munchies.

Since conference content is not always the most energizing material, SDDOL made sure that attendees were never at a want for something to do. Whether it was evening excursions to Deadwood, afternoon getaways to Custer State Park, Black Hills Harley Davidson, or scheduled dinners at Crazy Horse Memorial or Mt. Rushmore, there was *always* something going on to keep attendees occupied and happy.

The scheduled evening meal at Crazy Horse Memorial on Sept. 13 was a tad chilly, but attendees still enjoyed themselves and many got to meet Ruth Ziolkowski, matriarch of the mountain sculpture.

In addition to the beautiful scenery and the inspiring story of the mountain, attendees were treated to the laser light show displayed on Crazy Horse after dark. This is the first summer for the

laser show and it proved to be fascinating.

The conference culminated with a very special evening at Mt. Rushmore on Wednesday, Sept. 14, with a short speech by Mt. Rushmore superintendent Gerard Baker, a wonderful dinner at the visitor center, and a video shown on the amphitheater big-screen after the lighting ceremony, starring attendees and the activities held during the week.

Dozens of the attendees sought out staff members during the conference thanking them for a wonderful time. It was not uncommon to hear "this was the best conference I have ever attended, bar none." Even the vendors present had an exceptional conference stating that visitations and sales at their booths were the best they ever had at a conference.

Simply put, South Dakota "got 'er done" with a lot of hard work, dedication, and support of dozens of SDDOL staff.

## International president slated to attend District X Conference

# Darla Bockorny recaps 25-year career

**Editor's Note (by Jane Merrit): A retirement open house is set for Friday afternoon, 1-4 p.m. on Sept. 23, at the South Dakota Career Center in Brookings, to honor manager Darla Bockorny. Because of the significant role Darla played in the formative years of my own career with South Dakota Department of Labor, I take editorial liberty to publish this special tribute to her. When I started as a Job Service Representative in Brookings in 1989, Darla was responsible for training me, which placed her naturally in a role as mentor to me. The high respect I gained for her as I watched her do her job made the decision to join IAPES a no-brainer when the invitation to join came from Darla. Earlier this year, when Darla's daughter, Linnea Solem, served as keynote speaker for the IAWP state conference in Watertown, I asked Darla to share some memories, which follow here, in Darla's own words.**

I started at "Job Service" April 14, 1980. Jobs were very hard to come by at that time and the only thing open was the "front desk" job. I happily applied and accepted that job (for \$3.83 per hour, increased to \$4.10 per hour in July, which was tough with two children to support) thinking that I would see every job order that came in and I would be out of there or would get promoted.

In 1981 I was promoted to Job Service Representative and became a man-

ager of the Northeast Area in 1995, and Brookings Career Center manager in 2001.

I was part of the Employer Relations Team for several years in the 90's before going into a local office manager role. I've had various other special duty assignments over the years.

I joined IAPES in 1980 (fall) and was recruited by Fred Binder and Rich Husman, I think. I attended my first IAPES Educational Conference the next spring, in 1981, in Yankton, and received (to my surprise) the Outstanding Performance Clerical Award (that was a State Chapter Award we used to give). I've continued membership since that time and have only missed about three State conferences during that time.

I've held most sub-chapter offices, some more than once. I was South Dakota Chapter President 1986-87. During that time we started the fall "One Day" event designed for new membership growth to acquaint people with what their professional association, IAPES, was all about.

I was committee chair of Award of Merit, Legislative Affairs, and Education over the years. Also chaired the 1993 South Dakota IAPES Educational Conference that was held in Brookings, and helped with the 1982 conference. Then when I moved to Watertown in 1995, we hosted that conference as well, though most of the work was already well planned by the time I moved there in November, before the spring conference.

## A Reminder from the Awards Chair

Let's remember to be on the lookout for our documentation for the award nominations we are planning to make right after the first of the year.

Take a look at our South Dakota IAWP website for additional guidance. There is a wealth of information for awards on both the International and South Dakota websites.

**We have some very deserving co-workers and partner agencies who have done and are doing a tremendous job. Let's get the word out with a nomination from IAWP!**

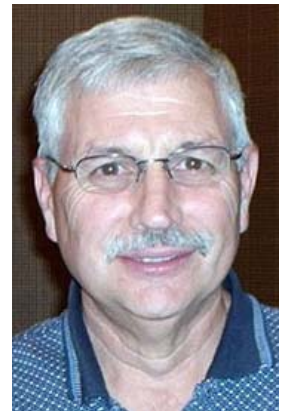
Check the website for a list of the various award categories and criteria for each award. Then use the online nomination form to fit the required information into the proper format and see what happens.

**Margaret Dethloff** from Moss Point, Miss., had moved her mother and herself from the coast prior to the hurricane. She has relocated temporarily in Jackson, Miss.

**Gail Grice** from Jackson, Miss., reports she and her family are fine, but the gasoline shortage, etc., is awful.

**Margaret Fletcher** from Baton Rouge, La., apparently is okay.

**Linda White** from Livingston, La., reports she is fine. Her daughter and family have lost two vehicles and two homes (one in Louisiana and one in Mississippi.)

**Eddie Filce, Bernard Blank, Lonnie Rogers, and David** (?) of Louisiana, whom many of us have seen numerous times at the international conference, are all okay. Eddie reported his home was without power for four days, and he had slight roof damage. Eddie is in Morgan City about 50 miles west of New Orleans, where they are taking many Unemployment Insurance claims. However, because of their close proximity to the gulf, they are not being set up as an evacuation option for the New Orleans citizens.
